## 1. What's Included

The purchase of each NomixClicker device for the presale price of **\$99** (regular price: **\$219**) includes:

- 1x NomixClicker hardware board (development-grade; no protective casing)
- 1x adapter for simultaneous power supply and iPhone connection (Apple Camera Adapter or equivalent)
- Worldwide delivery via registered postal services
- **Free subscription** to the NomixClicker web control service for 1 year, starting from the registration of your first preordered device on the NomixClicker platform
- After the first year, continued access to the NomixClicker service will cost **\$10 per month** per account

## 2. Delivery Timeline and Refunds

If Nixon FZCO fails to meet the stated roadmap deadlines, customers will be entitled to a **full refund** of the preorder amount upon request.

Customers may also request a **full refund** for any reason **before the device has been shipped**.
